

## Spring 2017 - Two Payment Plans to choose from:

### 1. MONTHLY PAYMENT PLAN

If you are not receiving any financial aid, this is the plan for you. It allows you to spread your payment over several months.

Dec 20	15%	4	Jan - Apr
Jan 15	25%	3	Feb - Apr
Jan 25	35%	2	Mar - Apr

### 2. PENDING AID PAYMENT PLAN

If you have applied for FAFSA but have not been awarded aid, this is the payment plan for you. To qualify for this plan, you must:

- Have a valid FAFSA on file but have not been awarded Financial Aid
- Be maintaining Financial Aid Satisfactory Academic Progress
- Be enrolled in at least 6 hours

*You must pay any balance due after your aid is disbursed.*

#### **Important Information:**

1. The payment methods for both plans must be from an automatic bank payment (ACH) or a credit or debit card.
2. All down payments are processed immediately.
3. There is a \$25 per semester nonrefundable service fee.
4. Monthly Payment Plan payments are due on the 5th of each month and continue until the balance is paid in full.
5. Pending Aid Payment Plan payments are processed on the 20th of each month and continue until the balance is paid in full.
6. There is a \$30 fee if a payment is returned.
7. You must visit your campus Business office to CANCEL your payment plan.
